1. PURPOSE AND ACCEPTANCE

For any dispute relating to the interpretation, validity, performance or termination of these Terms, the Court of Reggio Emilia (Italy) shall have exclusive jurisdiction, without prejudice to any mandatory provisions applicable where the counterparty is a consumer.
